- 2) That the person accompanying the minor will be responsible and will ensure their well-being, safety and compliance with the regulations, for all purposes, from access to the facility, during the event and until they leave the venue, in accordance with the obligations and provisions set out in the applicable regulations for the holding of public events. In this respect, the person in charge must accompany minors from the moment they enter the facilities until they leave them, remaining with them inside for the entire duration of the concert, ensuring their well-being and physical integrity;

- 3) Accept the general conditions of sale of the tickets purchased for the event;
- 4) To be aware that alcoholic beverages and/or tobacco are supplied in the venue to adults and, therefore, authorise the identification of minors for the purpose of indicating their age and restricting alcoholic consumption, assuming my responsibility to avoid consumption or any situation of risk or danger to minors or that they themselves may cause.
- 5) To respect the indications of the professionals working at the event;
- 6) To accept and firmly agree that the organisation will not refund the amount paid by the minor or refuse entry to the venue in the event of having failed to comply with any of the conditions or not having provided the correct and necessary documentation. It is understood that failure to comply with any of the above points may result in the expulsion from the site of both the guardian or authorised person and the minors.
